Members may receive an IPPE <u>or AWV/PPPS and</u> a routine physical exam on the same day from the same primary care physician as long as all components of both are provided and documented in the medical record. **For employer groups Benefit contingent on plan design.**

- (1) The first annual wellness (AWV) visit can't take place within 12 months of the "Welcome to Medicare" preventive visit (IPPE). However, "Welcome to Medicare" visit is not required in order for the member to be covered for annual wellness visits after they have had Part B for 12 months.
- (2) If you also bill other services with these visits and these services are normally subject to a copayment or coinsurance that copayment or coinsurance will still apply even if the primary reason for the visit was the IPPE or AWV/PPPS. Benefits, premium and/or copayments/coinsurance may change on January 1 of each year.
- (3) New in 2018 routine physical exam CPT 99385-99387; 99395- 99397 is at zero cost share for all members.
